

#### **California Trails Conference**

With "poop patrol", "continued access" to public lands (i.e. horses being left out of federal trail grants, because some bureaucrats don't consider them transportation), "sharing trails" with other uses, specifically bicyclists, etc., I thought this would be a

good time to remind you all that the California State Trails Conference is scheduled for March 25-28 in historic Folsom, California. This years' conference is located in Folsom specifically to accommodate horses; there are 30 miles of MULTI-USE trails for you to enjoy. In the past, these Conferences easily accommodated bicyclist and hikers but not horses. As the Equestrian member of the State Trails Committee, that was my first request. I think that, coupled with the fact that three people showed up at last year's Conference in Tahoe WITH HORSES (and no place to put them) has helped them realize they need to accommodate us.

So, please send someone from your organization, club, group or riding community to the Conference to demonstrate our interest and effect on trails, past, present and future. Go to <a href="www.rec-trails-conf.org">www.rec-trails-conf.org</a> for more info. I am also on the B.O.D. for The California Trails and Greenways Foundation. We are granting a \$500.00 scholarship for Conference Attendance this year. If you are, or know of, an equestrian representative that would be an asset to the conference and can't afford to go, e-mail me.

Also, I will be on an Equestrian-Bicyclist Panel, and will appreciate your input about sharing trails. I, for one, have been very impressed with the "oddeven" days policy at several parks where sharing just hasn't worked due to speed, spooky horses, blind curves, steep terrain. This policy provides that "horses can be on all trails every day. Bikes can be on trails on the even days of the month, i.e., 2, 4, 6, etc." This gives people the option of sharing or not sharing and still meets the public land use requirement for sharing of resources, aka trails.

I welcome and value your thoughts and opinions. I hope some of you will get involved.

He is only the second distance horse to achieve this honor; the other one is Irish Coffee '76 is also owned and ridden by Marilyn. She owns two of the six horses to achieve this high honor. Marilyn has completed 3.000 miles of endurance riding, giving her a total of 5,000 miles of distance riding in both endurance and competitive trail.

#### TAKE YOUR PICK

This little article is interactive. After having read it, you can respond with a choice reflecting your views of the workings of the County's Parks and Recreation Department. Believe me, had I been able to have success as a trail volunteer (encouraged by County publicity and described below), I would not have written it. Here goes:

Over the last few months I had noticed advertisements for the County's Volunteer Trail Days, and I was interested in helping. On Friday morning, January 9, I called the County's Volunteer Coordinator (408/355-2264) to ask for information about the Saturday, January 10, Trails Day work on Quicksilver Park's Prospect #3 trail.

I did not get a reply to the voice-mail message that I left, so I checked with the County's web site. It showed the many scheduled Trail Days, but it had not been updated and it contained no detailed information about the January 10, Trail Date.

Nevertheless, I decided to show up at the Hacienda Staging Area (which I had been unable to verify was even to be the staging location) at 8am and take my chances. My running partner, Pat McDonald, accompanied me. We were ready for trail work on that brisk, but, beautiful, Saturday morning.

We arrived early to make sure we would be in the work-party, but no one from the County was there. We hung around and, eventually, with the arrival of a Park Ranger, learned that there was to be no Trail Days. So much for good intentions. We headed for Starbucks knowing there would be no disappointments there.

Monday, January 12, I called, again, the County's Volunteer Coordinator, and, again, got the voice-mail. I left a complaint about the lack of a call-back and the out-of-date web site. Later, having discussed the situation with other people, I called a +County Parks trail coordinator named Greg Bringleson. Once again, I had to leave a voice mail, and, again, I aired my complaints.

That afternoon, Greg returned my call (I never did get a return call from the County's Volunteer Coordinator). He said that the Prospect 3 Trail

Day (as well as others) had been canceled last November, 2003, because of concern about the weather; he acknowledged that the web-site had not been updated; he apologized for the breakdown in communication; he volunteered that the County should be updating and disseminating valid information; and, he informed me that the County should be doing a better job. I agreed and thanked him.

So, now the question. Is this a breakdown caused by a County staff that is so beleaguered that it cannot answer its phones and cannot keep up with its workload? Or, is this a breakdown caused by an insulated and unengaged County staff that does not take its job seriously?

# WHERE HAS OUR OLD QUICKSILVER PARK GONE?

That is what some of us would like to know. Remember the days when you could ride in the park with no worries and truly enjoy being there (well, depending on which horse you were riding), I myself miss those days. They seem to have slowly disappeared. Where are those day when deciding factors of whether you were going to ride or not simply depended on things as, you would but the horse is lame, horse lost a shoe (nothing easy about an easyboot), or my best riding buddy could not go because she has housework to do, how lame is that.

Here are a few questions that would greatly benefit our attempts to regain those simple times so dearly missed. Remember your opinions and suggestions are important.

- 1) Are you satisfied with the current management of Quicksilver Park?
- 2) Do you feel reluctant to ride in the park for any specific reason?
- 3) Have you or anyone you know had any unpleasant encounters that park management could have handled differently?
- 4) If you could change or add anything relating to that experience stated above what would it be?
- 5) Finally, do you have any concerns or unresolved issues pertaining to riding in this park, that could be presented to the Board of Supervisors on your behalf.

My reasons for these questions are a direct result of numerous incidents that my friends and I have encountered over the past few years. Recently, Park Rangers informed us that not only could we not rider out of our back gate, but could not step out the back gate onto the park property. It seems that my friends and I are not the only landowners who have been approached with similar notifications. My experiences and those recently brought to my attention, continue to reflect a "management style" that enforces rules and regulations in ways that may be interpreted to single out the equestrian users of the park.

I think it is safe to day that a lot of us have felt our riding schedule is becoming more and more dependent on whether or not the park is open,

closed, undecided... as to equestrians. There are several parks governed by the same management, however, only two of those parks close while the others remain open. This is in comparison to years past when the parks were for the most part open.

In recent conversations with several landowners, whose property border Quicksilver Park, it has become apparent that many of them have become dissatisfied with the current park management. There appears to be a lot of inconsistency with the enforcement of park regulations. This is not to say that we do not have some great Park Rangers, because we do, but upper management definitely has some issues that need to be addressed.

We all have the same goal in keeping our parks a clean, safe and enjoyable environment where wildlife and humans cross paths. This land was donated for everyone to enjoy. There is a lot of

#### FIRE MOUNTAIN RIDE - 2004

One thing I appreciated was the fact that the three rides started an hour apart from each other. If you have ever been on a temperamental horse, starting after the pack so you can get control, and then had a group of people in the later ride come blasting past, you know what I mean. An hour difference is helpful for riders on a communal trail where everyone is doing loops in the same order.

I was disappointed to miss the Death Valley Encounter. The Fire Mountain Ride, 2 1/2 weeks later, compensated somewhat. It wasn't a multi-day, but it was a great one day ride in the same country. If the holidays are too complicated to get to Death Valley, I recommend this one. It is a wonderful antidote to a gloomy January.
