Accommodations: The base camp is located at the Desert Empire Fairgrounds in Ridgecrest, CA. 520 S. Richmond Rd, Ridgecrest, CA 93555. The elevation is approximately 2,500 feet. Motels, restaurants, and grocery stores are available two miles from the fairgrounds. Although the weather is generally nice, you should be ready for cold or wet weather. It is cold at night, near freezing, but can be warm during the day. It can also be windy. Saturday evening or Sunday morning awards breakfast can be purchased for \$15.00 per meal. One meal ticket is included with your entry and can be used for either the Saturday dinner or Sunday breakfast. Wonderful Casa Carona is catering again and the food is fabulous. Plenty of water is available at base camp for horses and humans. Bring a hose. A limited number of stalls are available (20). Stalls are \$30.00/night Pens were not available in 2017 we will have to see when we get there for 2018. Please enclose fee with entry to reserve a stall. You may pay a \$10.00 fee paid to ride management to have your camp cleaned up or you should bring tools to clean your camp and stall. Dogs must be kept on a leash at all times. The fairgrounds does not allow glass containers of alcohol.

Saturday trails: The trail consists of two loops for the 100 and 50; one loop for the 65, 35, and 15 mile rides, all beginning and ending at base camp. There are a few long gradual grades, and some rocks and sand. Pads are recommended for rocks which are primarily between Vet Checks 1 and 2 for the 65 and 100-mile rides. The trail will be well marked with plenty of ribbons, chalk and glowbars after dark. The introductory ride will be one 15-mile loop.

Saturday starting time: The ride will start at 6:00 for the 100 mile ride, at 6:30 am for the 65, at 7:00 am for the 50 mile ride, at 7:30 am for the 35 mile ride and at 12:00 pm for the 15 mile fun ride.

Awards: There will be first place awards for the 65, 50 mile and 100 mile rides and completion awards for all who complete the ride. A Team Award will be awarded for teams of four who are competing in the same distance. Enter your team when you register for the ride. All rides will have an AERC Best Condition Award. The 35 and 50 mile awards will be given out at the Saturday evening dinner and the 65 and 100 mile awards will be given out at the Sunday morning awards breakfast. Awards will not be mailed out and must be picked up at the ride. Fun riders will receive their awards upon completion.

Pre-Ride Vet Check: 3:00 pm to 6:00 pm on Friday, February 23. A pre-ride meeting will be held at 6:00 pm on Friday evening. For riders arriving in the morning, please make arrangements with the ride management.

Rules: All AERC rules will apply. Any abuse by rider or their crew to ride staff will result in disqualification of rider. Full refund for cancellations prior to 2/18/18. For cancellations after 2/18/18 and for horses not passing the pre-ride veterinary exam, a \$50.00 ride management fee will be withheld. No shows receive no refund. Checks will not be cashed until after the ride. Dogs must be on a leash. All hay and manure must be picked up and put in the large pile in center of fairgrounds, or for a \$10.00 fee paid to ride management we can clean up your campsite. The fairgrounds does not allow glass containers of alcohol.

Directions: From the Inland Empire: North on I-5 up the Cajon Pass to 395 North. Continue North on 395 to the Ridgecrest turn off — China Lake Blvd. Continue on China Lake Blvd about 5 miles to a light at Walmart and Albertsons. Go through the light to stop sign at Bowman Road and turn right. Turn left on Richmond Road and go to the North entrance of the Fairgrounds. From Los Angeles: North on I-5 to Highway 14 towards Lancaster. Continue North on Highway 14 approximately 120 miles to Highway 178 East towards Inyokern. Continue East on 178 (Inyokern Rd) approximately 14 miles to China Lake Blvd. Just past McDonalds turn left onto Highway 178 (Ridgecrest Blvd.) at the light. Turn right at light at Richmond Rd. The Fairgrounds will be on your left. From the North: Drive south on highway 395 to the Ridgecrest turnoff. Turn left on Inyokern Rd. 

Important—Upcoming XP Ride

From The Duck on the XP Rides FB page: Eastern Mojave XP Ride

January 27

The ride is scheduled to start on the exact date of the next government shutdown. Starting last Friday the 19th, before the first shutdown of the federal government I requested an opinion from the National Park Service about the status of the ride should the government remain shut down during the ride. I did not receive an answer. When the government reopened on Tuesday the 23rd I again tried to call and did not receive an answer. I sent an email again at that time explaining we had people coming from Canada and the east coast and needed to know ASAP regarding the status of the ride. After not receiving an answer and not getting through on the phone I tried another email nicely explaining our predicament. Again no answer.

On Friday the 26th I called again, got no answer from the permit officer. At that time I requested to speak with the superintendent of the park. I was unable to contact that person but the receptionist assured me I would receive a call that day. The call never came. I have continued to check all day Saturday for a message but none has come. The bottom line is that the National Park Service is completely ignoring my pleas. I have no choice but to look for an alternate site for this event.

Fortunately, the manager at Rancho San Fernando Rey has agreed to allow us to hold the ride on the ranch, which is the location of the Sesenta Años Ride. The ranch has turned green and may even have some wildflowers by ride time. We have some easier loops in mind for the event and our current plans are to wait until 10:00 AM on Monday morning for one final try to connect the park but I hold out little hope for a positive response. Obviously we can not ask people to drive to Cima Road with a chance the government will shut us out at the last minute. The only chance of bypassing a decision from the NPS is for the government to agree to some funding measure that will go past February 11th. Fat chance of that. We will contact everyone informed via a posting on this website and the XP Facebook page. The good news is that we will definitely have an XP Ride on these dates.

February 8-11, 2018 50 & 25 or 30 & 10 or 15 each day

Updated Monday January 29th 11:00 AM.

We have received sufficient encouragement from the government representative that we are willing to go to the brink of disaster by waiting till Wednesday night, the 31st of January to move the ride. I also have received some encouragement from officials in Ridgecrest they would allow us to use our standing permit to piece together a ride in the Ridgecrest area. Therefore, as of this moment we are planning on holding the ride at Cima Road. Therefore, our second choice for a different venue would be Ridgecrest/Inyokern. The last resort would then be Rancho San Fernando Rey. The best I can do is keep everyone posted both on the website and on Facebook.

A Letter to Quicksilver Members

Dear Quicksilver friends: I am writing to ask that you look into, and become a bit familiar with, the situation with Region VII in the Middle East.

As with many other things, we all have different opinions about our sport. What sounds good to me, may not sound good to you, but I am fairly sure that we all agree that the welfare of the horses is paramount. Sadly, although there is at least one barn in Region VII that seems to really take good care of their horses, the vast majority fall in the unreasonable racing speeds, drug violations, cars chasing the front-runners to keep the horses going, and an alarming number of catastrophic deaths out on the course category, not to mention horses that just plain disappear.

I firmly believe that it is only a matter of time before animal welfare organizations get involved in this, and we will ALL suffer the consequences. Endurance as we know it will be wiped off the map, and all because of a small group of people that only care about fame.

I have written to the AERC asking that they do more than write stern letters of protest. This has been done several times with literally NO progress. I believe that it is time to put some weight behind those letters and take action. I don't know what is the best solution to this problem (other than install a conscience into some folks!) but I know that peer pressure is a powerful thing. If the AERC and its members withdraw from participating in Region VII events, the rest of the world will probably follow. Maybe that will get their attention.

When I wrote to the AERC Board of Directors expressing my dismay and disappointment, I actually received some positive responses. I believe there are some on the board that feel as concerned as I do about the deaths of so many horses, some of which probably came from the US!

The AERC BOD will be meeting in February, and this issue is on their agenda (see https://aerc.org/static/Temp/DraftAgenda021218.pdf)
