#### Michele's Birthday Present

This story really starts with a bay mare named Cougars Clown. Some of you may have known her. She was by Cougar Rock by Bezatal, out of an Indian Pony mare, and she was best known for her half bald face opposite a striking blue eye. In 2007, she gave birth to a filly I named Clowns Charisma, but call Pippa, because she was quite a little pipsqueak when she was small!

Call me crazy, and maybe I was at the time, but there is something about those babies that is addicting, and last spring, I decided to give Pippa a chance to carry on Clown's tradition of excellent motherhood. I missed her May heat, but all seemed fine for her in June, and she was bred over Father's Day. Just to confirm that all was in order, I ran a blood test for pregnancy in September, and was dismayed to get back negative results. Oh well, c'est la vie, as they say. Apparently, Pippa did not want to be a mother, so I increased her training, with an eye towards an LD sometime the spring of the following year.

The foal still did not seem to have turned, and she was not dripping any milk, so I set the alarm for 2AM again, but without any thrill of anticipation.

As had become my habit, when the alarm went off, I rolled out of bed and into some clothes conveniently placed on the floor in front of my bed with my eyes still halfway glued shut. Grabbed two carrots out of the fridge, and trekked outside into a beautiful, moonlit, mild, calm night, quiet and still but for the crickets making their serenade. As soon as I got out to the gate, I knew something was happening. I did not need a flashlight, because the moon is near full, and it was casting a benevolent yellow light over everything. But....the horses just had an air about them. I could tell something was happening before I even really unglued my eyes and saw them.

With these things, there is always a waiting to see....is everything okay? Is it all coming out the way it should? There is so much room for disastrous results, and of course, being the veterinarian, I am always halfway expecting the worst. So I was not shocked to see part of the amniotic sac sticking out, and nothing much happening. This is never a good sign. I gave an attentive Tallymark a carrot, and Pippa ate the other one, just like nothing was happening! Now that's an appetite any good endurance horse would be proud of!

Then I got down to business, still with the feeling of "how bad is it going to be?" hanging over me. The parts I could touch were cold, so I was not sure how long this had been going on. I quickly determined that everything was where it should be...front feet first, offset and parallel, and I could feel what seemed to be a fairly good-sized head...no surprise about that, being that it was Clown's grand-foal! I still had not turned on a flashlight, as there was no need. I did not see any blood or anything amiss in the moonlight. So......I grabbed hold and gave a tug. This didn't budge a thing, but it did get Pippa's attention, and she started pushing again. I think she'd given up on that part. A little more of this ensued, and Pippa decided it was time to lie down, which she did. I think this was helpful, as we made a little more progress. I was pretty sure the foal was going to be dead, at this point, and I was just trying to get it out to save the mare (remember....I am always thinking worst-case scenario!). I had to put my foot up on Pippa's rear end and pull for all I was worth, feeling like I as at least tearing muscles on the baby, if not actually dislocating a shoulder. Finally, the darn thing came out, and I tore open the sac over her muzzle, and she started to move!

After that, Pippa rested for a while, I rubbed the baby all over to get her stimulated, all the time having dreadful visions of all the dummy foals I worked on in vet school (those are the ones who come out okay, but never get the instinct to stand up and nurse, and ultimately don't survive).

It's kind of like checking things off a to-do list: get it out, make sure mare is not bleeding to death, make sure foal is breathing, standing, nursing, make sure mare will let foal nurse (maiden mare....they dont always like it!), make sure mare has milk for foal to nurse, make sure placenta is out and whole.....it goes on and on.

With everything checked out, at last, I can sit down on the clean dried grass that smells like summertime hope and breathe a sigh as the weight of this magical moment under the nearly full moon envelops me. We are alive, and whole, and tonight, Clown's spirit carries on.

Now, I am for coffee and a shower. I think I have afterbirth in my hair!

Note: the filly is named Charismas Hot Flash, and she weighed in at 114 pounds! She is now a week old, and looks to have already grown an inch. Pippa is healing well and is a very good and content mama.

But the fun of it all, once our little group started dreaming about 'the possible', knowing that NO ONE would understand our insanity, is we still decided to TRY!



#### "Ride Bear I & II"

SEPTEMBER 22<sup>ND</sup> AND 23<sup>RD</sup>, 2012 50 Miler, 25 Miler and SHORT FUN RIDE!

A TRULY UNIQUE "THIS-EVENT-ONLY" COORDINATION OF TRAILS CONNECTING TWO BEAUTIFUL PARKS OVER PRIVATE PROPERTY AND OPEN SPACE! Our exciting annual fall ride benefiting the Western States Trail Foundation, a not-for-profit, will once again be offered as a multi-day event from a spacious base camp. Ride Management continues to work collaboratively with OSA (Open Space Authority), supportive private land owners, County and State officials to realize the vision of linking Harvey Bear County Park with Henrey Coe State Park. Please note: because of the nature of working with 3 different government authorities and private property owners, these trails are open only once per year. Maintaining this sensitive arrangement greatly depends on how you treat others while attending.

#### WE LOOK FORWARD TO WELCOMING YOU AT RIDE CAMP!

CAMP INFORMATION: Camp is located at the Coyote Lake-Harvey Bear Ranch County Park. This ~5,000 acre park featuring a 635 acre lake with miles of horse, bicycle and hiking trails - is nestled in the Diablo Range east of the City
of Gilroy. There are three entrances into Coyote Lake-Harvey Bear Ranch County Park. Our ride site will be at the
Harvey Bear Ranch. Dogs are welcome on a 6 ft. leash at base camp only. From U.S. Highway 101 (between Gilroy
and Morgan Hill), take the San Martin Ave. exit. Proceed east on San Martin Ave. for 2 miles. The park entrance is on
the left, one-quarter mile east of Foothill Avenue. RIDE CAMP IS JUST BEYOND THE MAIN ENTRANCE TO THE
PARK. Creek and hydrant water, both in camp and at appropriate intersections, are suitable for horses only. Riders
should bring their own drinking water. Portable toilets and trash receptacles are provided. NO OPEN FIRES ALLOWED.

RIDE DETAILS: Day One for the 50 milers (only) will start in Harvey Bear Park, go through 10 miles of technical new trail to include Open Space and Private Property, and include a loop in Henrey Coe before returning home. Day Two will incorporate the original Harvey Bear trail and feature the Savannah Trail with beautiful vistas of Coyote Lake and the valley below as well as other newly opened trails.

- PRE-RIDE VETTING: Upon vet arrival (usually about 4:00 PM) 7:00 PM Friday. Multi-day riders please bring your second day rider card to your first day completion exam.
- FABULOUS MEALS: PRE-RIDE POTLUCK on Friday starts at 5:30 p.m. Please bring something to share with our
  wonderful group of riders and volunteers. Prizes for "Best in Show" will be given (2 categories Entrée and
  Dessert). Wine tasting on Saturday starts at 5:30 p.m. with Dinner. Pre-Ride Briefing at 6:30 PM both days.
- RIDE TIMES: 50-milers 6:00 AM 6:00 PM; 25-milers 6:30 AM 12:30 pm; 10-mile Fun Ride 7: 30 AM UNTIL YOU'VE HAD ENOUGH FUN (but please, prior to 5:00 PM so we can check you in prior to having dinner together)!!
- IMPORTANT REMINDER: 25 miler placements are based on the order in which the horses meet a heart rate of 60 beats per minute (and required prior to 12:30 p.m. as additional criteria for completion).
- POST-RIDE EXAM OF HORSES: Based on AERC current rules and control judge Bill Seales criteria for then current
  conditions. All criteria will be posted at the check-in table upon arrival and shared at the ride meeting.
- AWARDS: Official awards will begin at around 6 p.m. and will be given to ALL Riders participating, including Top 10 for 25/50 mile riders as well as special awards for FUN RIDERS!
  - ✓ BEST CONDITION: based on AERC established criteria for all Sanctioned Distances
  - ✓ MULTI-DAY RIDERS: as in the past, special awards will be given to riders/horses completing both days.

RIDE RULES: The 50-mile and 25-mile rides are sanctioned by AERC and will comply with AERC rules and policy. The Fun Ride is sponsored by Ride Management and is put on for the benefit of those that want to enjoy the trail as well as those wanting an introduction to the wonderful equestrian sport of endurance. All horses entered in the ride will be under veterinary criteria. Our knowledgeable Volunteers will be helping all riders with/without experience to understand the criteria as well as how to present their horses at the vet checks. Additionally, Ride management reserves the right to interpret the rules as would be necessary to insure the continuity of the rides and to settle any questions which may arise from any incident that might occur during the rides. Minors (under 18 years of age) are required to wear helmets. All other riders are STRONGLY encouraged to wear helmets.

#### INFORMATION WE CAN USE

#### From Mike Maul:

I'd had two tires on my trailer blow out on my last trip to a ride. This was a reminder that one spare may not be enough. I also use a drive-up on jack and found it's not too useful when both tires go out on the same side...

I replaced them and decided to read up on trailer tires. I've been treating LT and ST tires as equivalents and they really are not.

Here's an interesting link with some things I didn't know about trailer tires.

http://www.discounttire.com/dtcs/infoTrailerTireFacts.dos

An "LT" designation on a trailer tire size specifies load range only. It is not designed for use on light trucks.

Always inflate trailer tires to the maximum inflation indicated on the sidewall.

All "ST" tires have a maximum speed rating of 65 mph.

Trailer tires are not designed to wear out.

The following seems really low to me...

The mileage expectation of a trailer tire is 5,000 to 12,000 miles.

ST" tire rubber compounds contain more chemicals to resist weather and ozone cracking.

The ST polyester cords are bigger than they would be for a comparable "P" or "LT" tire.

Replace trailer tires every three to five years, whether they look like they're worn out or not. ( Mine have not lasted three years ever...)




