When I first bought a horse I had this idea that I would ride off into the sunset on some cowboy set in Hollywood. You, know the John Wayne type of adventure. Alas, after 6 years and a lot of sunsets I have yet to find the perfect picture. It has had a lot of close ones, beautiful mountain skylines with a tint of red on the horizon. Vast desert glowing in the after burn of a sun already set. Endurance riding certainly took me to places to see that dream.

What this is all about is seeing new places. It may be on a fifty mile or hundred mile endurance ride or it could be just cruising, finding a place that has it all. Last Saturday I found such a place. The State of California opened the FATJO PARK down by Pacheco Pass. Its an old working cattle rough that the Outer Inc.

down by Pacheco Pass. Its an old working cattle ranch that the State got for nothing, in fact it came with an endowment to keep it running. If they don't steal the dough for other purposes it cold make this park ideal. At least as I see if for horses.

So what's the big idea? Well, think of a view for miles in every directions. Think of rolling hills with vast meadows of wildflowers and green grasses that only a horse could love to chew. Dear Fellow Quicksilver Members,

If you don't accomplish a single other thing this week, the week will have been well spent if you could just write a letter to the Santa Clara County Parks & Recreation Dept. As most of you know, the chances of Quicksilver Park being opened up for bicycle riders is a very real threat. Basically most of us are in favor of multi-use trails and recognize the rights of others to access our park systems. However, In the case of Quicksilver, bikes and horses are totally incompatible. Most of the trails are steep where bicycles pick up great speed and most of the curves and corners are blind...an impossible situation for riders. Bicyclist tend to look at the ground directly in front of them with heads down and they frequently do not see a horse and rider ahead on the trail. A collision between a panicked 1,000 pound horse and a 180 pound bicycle rider is a disaster in the making.

Many parks lend themselves well to multi-use where the trails are in the open and the curves are long and sweeping. This is not the case in Quicksilver. So please, if you accomplish nothing else, do write a letter as directed below. A sample is given. An original letter is better than a form letter. The worse scenario is no letter at all. Please help save our Park for riders...it's long traditional use.

Dear Director Romero:

I am very concerned about safety issues raised by the possiblity of allowing more diverse trail use in Almaden Quicksilver County Park.

This park has many steep hills, blind corners, and places with no "emergency escape" space due to precipitous drops off one side of the trail combined with a steep bank on the other.

Certainly most adult park users try to be careful and considerate of each other. I am more worried about the youngsters who will ride bicycles and horses on the same trails, and who may forget to be careful, especially if they are out without adult supervision. And even the steadiest old horse may spook if run into from behind.

Please prevent potential disasters by continuing current trail use policies at Alamden Quicksilver County Park.

### A hearty thank you to Barbara McCrary for reporting on the two Board Meetings held at the February American Endurance Riders Conference's Annual Convention.

### Synopsis of AERC Board Meetings Held During Convention

The AERC Board of Directors held two meetings during the recent convention in Reno. Items discussed during the Thursday evening meeting were:

- Proposal by the Awards committee for a Rookie of the Year award one per region, seniors only,
  must have 250 or fewer miles prior to the season, one horse/one rider team, can travel to other
  regions, award given to highest consecutive completions. Issue tabled until it is determined what
  costs of administration will be.
- Junior point structure change passed during the midyear board meeting not to be enacted due to projected costs.
- Two-day 100 mile rides will continue to be sanctioned.
- · Committee appointed to formulate guidelines for appointment of stewards.
- Information will be gathered from the Members' Forum and Competitions Committee will develop recommendations regarding cash awards rides; to be presented at Sunday morning meeting.
- The Southwest Region divided into two regions one to include southern California and southern Nevada, the other to include west Texas, Arizona, and New Mexico. The latter will retain the name of Southwest Region, the new region will present its choice new name at a later date.
- International Committee met separately on the subject of "Marathon Racing" and will present its guidelines at the Sunday meeting. ("Marathon" refers to a 26 mile race format now taking place in the United Arab Emirates.)

### Items discussed at the Sunday morning were:

- Trails Committee chair Connic Berto reported that a liability act concerning equine-related activities in California has been defeated. AERC had not been on the list of petitioners. She feels this act will be reconsidered and asked for AERC support. During the Members' Forum, \$500 had been collected from the audience and another \$1000 has been pledged. This fund will help pay for members attending meetings throughout the country concerning trails.
- Two multi-day rides have been added to the "approved" list for 1997: Shore to Shore 5-day in Michigan and Applegate-Lassen Trail 5-day in Nevada. (This is the second year for A-L. If no negative issues arise from the ride this year, it will become automatically sanctioned in the future. S-S must be approved by the board for one more year.)
- The Board was called on the carpet for neglecting to introduce the Gold Medal individual and team winners of the World Championship FEI ride in Kansas during the Saturday night awards banquet.
- Treasurer reported a 6.7% decline in AERC membership. There is a need to increase membership and not increase expenses.
- Veterinary Committee chair Dr. Robert Beecher presented the committee's recommendations re: cash award rides: 1) They be designated as "Special Events", 2) They would require a specially appointed ride steward, 3) A trail inspection and approval, 4) Approval of ride manager, 5) Approval of veterinarians, 6) Horse and riders would be required to meet qualifications for entry.
- Competitions Committee proposed the following recommendations for Cash Awards rides: 1) Ride offering a cash prize of \$1000 or more must be sanctioned through Special Events sanctioning, 2) Cash or prize of \$1000 or more can be given only for a ride of at least 50 miles in length, 3) Cash or prize will be given out in accordance with sponsor's wishes, 4) Head veterinarian must be approved by Vet Committee, 5) 20% of cash prize must be given to AERC, 6) Horse must have completed 5 or more

rides of equal or greater length than the ride being entered, 1000 miles of completion required for multi-day events, 7) Riders must have completed at least 1000 miles.

- AERC needs to ensure that no complications with insurance programs or trail regulations exist.
- The various recommendations from Committee and Board will be published in a future issue of Endurance News.
- Rules Committee chair Courtney Hart moved for committee to change Rule 3.1 to read "Equines in a one-day 100 mile or longer distances must be at least 72 months old." Other age requirements remain the same. To be published in EN.



ALERT! CONCERNING LIMITING LIABILITY FOR EQUINE ACTIVITIES:

A new bill has been introduced by Bill Morrow from San Diego. The new bill number is AB 1540. We are up against an Assembly Judiciary Committe with ten Democrats and six Republicans. To date, most Democrats have voted no on our issue but All Republicans have voted yes. Bill Morrow is the Vice-Chair of the Judiciary Committee.

All members of the Assembly Judiciary Committe must be contacted. We must use letters, faxes and phone calls. If it passes this committee, then it would go to the Assembly floor. The next step would be the Senate Judiciary Committee and then the full Senate and then the Govenor.

This is not an easy process but IT MUST BE DONE. Please use the sample letter or better yet, use your own words. Make 16 copies and send to each person on the committee.

Dear Member of the Ridge Trail Council,

### We Need Your Help!!!

On March 4, the San Francisco Public Utilities Commission (PUC) voted 4-0 against the Ridge Trail. This vote followed years of public testimony which overwhelmingly favored the use of an existing service road in the San Francisco Watershed as an important segment of the Ridge Trail in San Mateo County. The Public Utilities Commission is obviously not listening to the public, and continues to allow the San Francisco Water Department (SFWD), over which it has authority, to maintain its renegade stance. Both San Mateo County and the National Park Service, which share jurisdiction with SFWD over the land, have long favored granting access to this public land via the Ridge Trail. The Ridge Trail would be a very low-impact and environmentally sound land use in the watershed, since it will follow an existing 9.5 mile service road.

### Please Write Now!!! This May Be Our Last Chance!!!

The San Francisco Board of Supervisors is currently considering a favorable motion which will direct the SFWD to complete the Ridge Trail in the Watershed. The hearing has been set for April 10, 1997. **This may be the last opportunity to achieve the Ridge Trail in the watershed for many years.** Before the hearing, San Francisco officials need to hear from as many supporters of the Ridge Trail as possible. We need to flood these offices with support for the motion from throughout the Bay Area.

If you have any connection to any official listed on the back of this page, please address your letter to that individual. If you have no connection to any of them, write to Supervisor Ammiano expressing support for his motion, and copy Supervisor Bierman and Mayor Brown. If you have friends who are San Francisco residents, get them to contact their elected representatives; letters from anywhere in the Bay Area are important, however. Letters can stress any of the issues listed in my first paragraph, or any others you may wish to raise. If you don't have time to write a letter, then simply cut off and mail the enclosed note to Supervisor Ammiano.

We are organizing public testimony for the April 10 hearing, which is at 10:00 am. in the 4th Floor Committee Room of 401 Van Ness Avenue (War Memorial Building) in San Francisco. If you can attend, please do. Public support has always been the cornerstone of our progress on the Ridge Trail, and I am convinced it will make a difference on this issue.

There is one more thing you can do to support the Ridge Trail: get out and enjoy it with your friends, and encourage them to become members. There is great strength in our numbers!




