

many by a poorly marked trail.

Almost everyone was off trail at one time or another and going around in circles and back tracking makes for some unhappy riders. Hopefully it was a one time occurrence because ride management is friendly and hard working.

ARE WE BURNING THE CANDLE IN BOTH ENDS? by Lars Larsen

"For a good pasture in the future, weed out the poisonus plants now "

We don't own the world — we are borrowing it from our children. We don't own this parks — we borrow our safe and sound usage from the other users (and need to try to hold on).

The mountain bikers don't own the parks either, but they have written down and published widely what they feel is a safe and sound

trail usage policy.

We as horseback riders need to write down similarly for horse use, including parking lots. And the parks need to do the same..how they feel the multi-users are supposed to behave. Then we can sit down and spilt hairs, or hold hands, and show the world that this can be done.

My 10 years of the Virl Norton School—on horses the former owners could not handle as animals, he did give a constant exposure to all and everybody—a saddle, wagon or horse was for you to use any time.

Horses can't distinguish the difference in the smell of the odor, between being scared or angry. This is a something the public needs to know. Horses like to lick the sweat off of your back. Let them do it.

Stop saying No. (what goes around, comes around). We need to mix with other user groups, learn how they enjoy the parks. How to get more trails for us all to use-need to move up to the top of our list (Trails are now a community effort, we get the trails we are willing to

build together). Before, you did take a ride. Now you give your horse a ride, sharing this trail with whatever you happen to meet. And since we are among the older and more experienced user groups, our horses did open most of the trails (we who ride to the right/left side to scout around the blind turns, to help to give more space. More signs I think will help.

We are fortunate to have the safe Coyote and Los Alamitos Creeks trails, to familiarize our horses with the modern world's activities. Stop and talk to other park users, let them and their kids and dogs learn about your horse. We must break down the iron curtain before it gets to high. We are all just plain people. Make videos about how some horses react to changes along the trails, and surprises, including other horses running on the trails.

These new members to our club now, starting out just blank (and for those of us who forget) monthly reminders of what you are sitting on and might be facing? (Look for other trail users to always slow down, stop and pass a horse quietly on the down hill side) For a good pasture in the future, weed out the poisonous plant now. (Wherever they are or come from. Some multi-use trails need to be one way direction only. Watch the alcohol on horse and family outings too.

Don't forget now, that the park personnel are comparing notes too, from all of our parks that is. You make sure that the horses always come on the top of their list

1997 PAN AMERICAN CHAMPIONSHIP by Jack Enderle

All right!!! Five a m and the trail is open...let's see now, for a while we'll have good footing, but must watch out for that rocky section just past the irrigation canal. Then there is that road crossing and bridge just past that scary culvert. Wow! What a pace the leaders must be setting....branch! Look out! Good Grief! When we prerode this section of trail several times over the last four days those branches didn't seem to be a problem...funny how different things are in the dark! The usual comments about flashlights ruining their horses night vision, several horses off trail in the brush and then back on trail...Next time, I think I'll pick a gray horse to follow...seems to work better in the dark! Thank goodness for the glow sticks along the trail...I suppose they are there for the rider's confidence as the horses seem to do just fine in the dark. Of course there was that time we were cantering along leading the pack at the Swanton Pacific 100 when Silver spooked and stopped dead in his tracks !!!! I'll leave it to your imaginations, as to where that left me..

Seems like the start of any other 100 mile ride, but this <u>is</u> the Pan American Championship and this ride/race is different from most rides we do. Because the nomination and selection process starts early in the year and is based on the prior two years riding record of the riders and horses, there is a lot of planning and luck involved, not to mention the \$300

passport and \$400 entry fee and 10 days off work!

Of the eighteen horse and rider teams who nominated for the Pacific South Team, there were only seven of us who arrived at Bend, Oregon in early September to hopefully ride for our team. The selected riders were: Heather Bergantz/HBC Tyler Too; Kirsten Berntsen/WSCallisto; Gary Ceragioli/Desert Rose Razz; Shirley Delsart/KJ Destination; Jack Enderle/Fad Silver; Barbara Sanchez/Calculator VA+/ and our one alternate rider Wendy Lumbert/Whip. All the rest were eliminated along the way for one reason or another or had chosen to withdraw prior to the selection of the squad. Disappointed (to say the least), but none the less enthusiastic, was Valorie Weizer whose horse Copper was eliminated at the last minute...and she had even gotten her passport! But she was there to help crew!

On a preride of the trail Heather's horse, Tyler, came in with muscle cramps or maybe it was thought to be a mild tying up, which eliminated them from even starting. Tough luck! She has her own story to tell about the trip up there with transmission problems, complete with truck on fire! Heather's elimination from the ride made Wendy Lumbert/Whip, our alternate rider, a squad member briefly, as they were eliminated at the preride vet in for lameness. This meant that we were starting only five on our squad instead of the possible six. The first check eliminated Barbara Sanches/Tor; the second vet check eliminated Kirsten

Bernsten/WSCallisto.

Quicksilver members who came to help were: Steve Lenheim, Brian Bergantz. Lori Oleson, Diane Enderle, Mike Bernsten. Talk about a crew!! Nancy Elliot was also there as an official ride vet. There were at least twelve people at the last vet check at about eleven PM to assist and spoil Silver and me. At the finish line there must have been twenty of the teams' supporters to watch and cheer as Silver switched from his "don't worry, we'll get there trot" to his crowd pleasing gait, and trotted handsomely to a successfully completed ride. The other squad members were not as fortunate as Silver and I and only two other members of our team finished the ride. They were Shirley Delsart/Dusty, who finished first for an individual gold medal and Gary Ceragioli/Desert Rose Razz...the three of us won a Bronze medal for the Pacific South Team!!

As you know, luck and timing play a big part in this endurance game. Most of the horses and riders that were eliminated throughout this adventure have since started and completed a ride.

Endurance riding was something I never envisioned myself doing as I trotted around in a well groomed arena for my weekly riding less-

ons as a child. While I did have a few experiences taking those big school horses out for a hack on the Novitiate property, it was just a special treat saved for rare occasions.

When I returned to riding in my midtwenties I had intended to pursue some casual showing--Country English sounded nice. That all changed once I got my two Arabians into a barn near my home in Rancho San Antonio Open Space Preserve. I remember very clearly the first day that I took my mare for a trail ride along some of the upper trails; the air was crisp, but the sun quite warm as we headed toward the top of the hill. This horse had

been quite a handful in the arena, so I was a bit anxious about cantering in a park with people around. i waited for a long uphill grade where I could see a good distance and legged her on. It took about two seconds for me to forget all my cares and worries and simply revel in the joy of a beautiful day with my friend. From then on it was trail riding for me.

I was introduced to endurance riding via NATRC. My best riding pal (and crew person Extrordonaire) Gill Tabb dragged me along to quite a few rides for about a year or two. I really enjoyed the camping with my horse and learned a lot. My only trouble was that my horse really felt that the pace was a bit slow! It was on one particular Swanton ride that in my quest for a solitary spot on the trail I got totally lost. I finally came dragging back into camp at the end of the day and was summarily disqualified from competition. Some of the kind P & R folks suggest that I go out and ride with the drag riders the next day as long as I was going to be there waiting for Gill anyway. I

hooked up with Judy Ethridge and Genine McCrary who were training for the Swanton 100. They spent a good deal of time trying to convince me that my horse was plenty capable of completing a fifty mile ride. By the end of the day I'd had such a terrific time that I

had decided to enter my first 50 mile ride three weeks later. I was hooked!



RULES:

- . The horses are under the control of qualified veterinarians. The veterinarian's decisions are final.
- 2. The ride is open to any breed or type of horse or mule, which must be 60 months of age to compete in the 50 mile ride or a minimum of 48 months of age to compete in the 25 mile training ride.
- Entry will be refused for but not limited to non-payment of fees or drugging of horse. Disqualification is abuse of horse, continuing ride after being pulled, unsportsmanlike behavior towards ride personnel or other riders or public trail users, altering trail markings, taking short cuts, changing riders, leaving timed holds early, or not following management guidelines.
- 4. Riders will have 12 hours in which to complete the 50 mile course and 6 hours to complete the 25 mile course.
- 5. All riders and their mounts must be present at starting time but may hold back for a maximum of 15 minutes. All riders and their mounts must report to the veterinarian for a post-ride check within one hour after completion of the ride. Criteria for successful completion of the ride will be given at the pre-ride meeting.
- 6. Placing will be determined by the order of finish of those who have met the completion requirements.
- 7. AERC will record points and mileage for AERC members as described on pages 8, 9, and 10 of the rule book.
- 8. All junior riders must be accompanied by a competent adult sponsor throughout the competition and must finish within one (1) minute of that sponsor. A junior is a rider who was under the age of 16 years on the first day of the ride season in which the ride is held. An AERC member who is 14 years or older, who has completed 500 miles may ride unsponsored, but will compete as an adult and must provide a letter verifying status for the AERC office.
- 9. Drugs of any kind are prohibited in all equines participating in all sanctioned rides. This means the only thing you may put in or on your horse is hay, grain, water, and electrolytes.
- 10. No smoking on trails.
- 11. AERC rules and guidelines apply as this is an AERC sanctioned ride.
- 12. Please be responsible and clean your camp area as this will allow us to utilize these grounds in the future.



Directions:

From Interstate 280 or 880 (Hwy 17) or US-101 take Hwy 85 to Almaden Expressway SOIJTH to the end. Turn RIGHT on Harry Road, then LEFT at the first stop sign on McKean Road.

.Base camp has been moved from the Santa Clara County Horseman's Grounds to Skip Lightfoot's Stables at 23100 McKean Road—across from Calero Reservoir.

Trail: There is a 25 mile and a 50 mile moderate course through oak-woodlands and rolling county park land consisting of fire roads. There are water troughs on the trail and one area with easy access to a creek.

Base Camp: Skip Lightfoot's Stables, 23100 McKean Road, San Jose, CA N.


